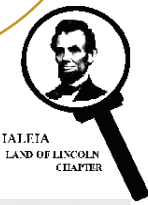

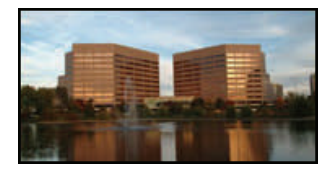

Many new crime trends have emerged domestically and internationally. As analysts it is imperative to know where to begin researching to make the links and identify other key elements of each case.



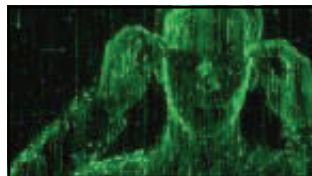
