CERTIFICATION

IALEIA has qualification standards and indices of competence for the profession and administers a professional international certification program. In 1991, IALEIA partnered with the Society of Certified Criminal Analysts (SCCA) to create a certification program for analysts. IALEIA subsequently adopted and assumed full control of the certification process. The IALEIA Certification Program is structured to encourage continuing education, measure knowledge and skills, and recognize excellence through experience.
